### **Student Accident Coverage**

The Kuemper Catholic School system does not offer or provide student accident insurance, nor is insurance required if a student does not participate in athletics. The following are guidelines for insurance coverage: 1.) Athletes will need proof of insurance before he/ she can participate. Proof of health and accident insurance can be provided on the Health and Injury Information Card. 2.) If there is no family policy to cover the student, there are two options: a.) Students who qualify based on need can purchase Hawk-I health care. More information on Hawk-I can be obtained at [www.hawk-i.org](http://www.hawk-i.org) b.) Short term medical and accident insurance can be purchased from a private insurance agent.

### **Asbestos Management Plan**

An asbestos Management Plan for Kuemper Catholic School System is available for review in the administrative office of each school building. This management plan is required under the federal "Asbestos Hazard Emergency Response Act" (AHERA) codified in 40CFR Part 763.

### **Corporal Punishment, Restraint, and Physical Confinement and Detention**

State law forbids school employees from using corporal punishment against any student. School employees may use "reasonable and necessary force, not designed or intended to cause pain" to do certain things, such as prevent harm to persons or property. State law also places limits on school employees' abilities to restrain or confine or detain any student. The law limits who, how, where, and for how long a school employee may restrain or confine and detain a child. If a child is restrained or confined and detained, the school must maintain documentation and must provide certain types of notice to the child's parents. ### **Family Education Rights and Privacy Acts Policy**

Kuemper Catholic School System will appropriately disclose student information that is not considered harmful or an invasion of privacy. This information includes, but is not limited to, name, address, telephone number(s), email address, photograph, date and place of birth, major field of study, grade level, enrollment status, dates of attendance, participation in officially recognized activities and sports, weight and height (athletes), degrees, honors and awards and the most recent educational agency or institution attended. If the parent or student (18 or older) does not want the school to release one or more of these pieces of information, a written directive must be submitted to the Main Office. The directive is effective from the date of submission and will continue as long as the student is enrolled or until changed by written directive. [Page 17 in the Student Handbook]
